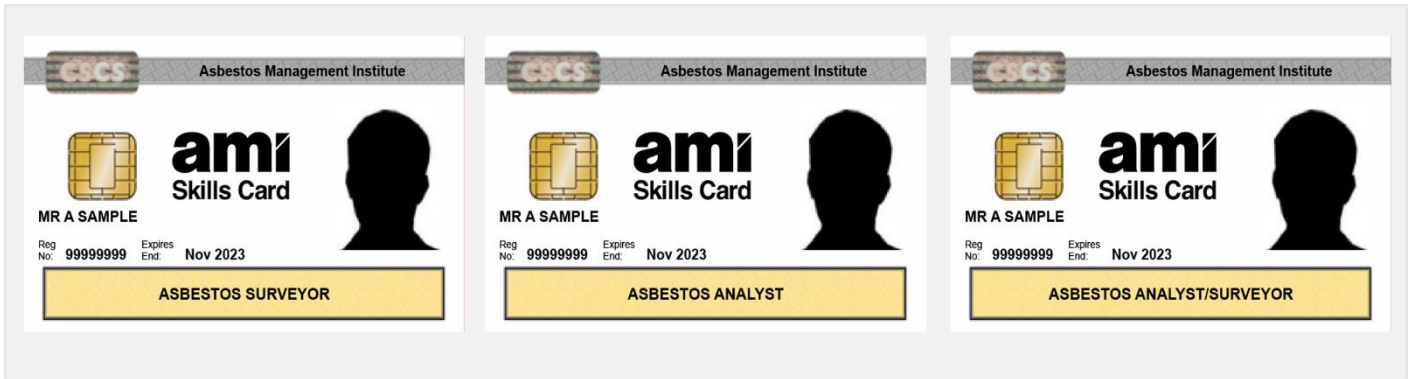




# AMI Skills Cards Asbestos Analysts and Surveyors



**ATaC operates the AMI Skills Card Scheme, which is a nationally recognised construction skills card scheme carrying the CSCS logo.**

All Partner Card Schemes display the CSCS logo and are based on the same standard as CSCS, often requiring the card holder to gain a nationally recognised qualification and pass a Health and Safety Test, though they may also have additional requirements.

By carrying the CSCS logo these cards provide a means to verify that people who want to work on construction sites have the necessary training and qualifications for the type of work they carry out.

All cards issued by ATaC use smart technology and contain an electronic chip. This can be used to check the identity of the card holder and, for example, when ATaC updates a card holders' record this will automatically update the chip in the card.

Virtual smartcards can also be issued to applicants, at no additional cost, if the applicant provides a personal mobile number and/or email address on the application form. A virtual smartcard is a smartcard that is stored in an app on the card holders' smartphone or tablet (this can be used instead of or as well as a physical card).


